Vendor Guidelines

Vendor Setup:

- All vehicles must be checked in and parked between 7:30 and 8:45 A.M.
- Vendors must be set up and ready by 8:45 a.m. The sale begins promptly at 9:00 a.m. and ends at 3:00 p.m.
- Once parked in the sale area, vehicles must remain until the event concludes. No driving into the sales area will be allowed after 8:45 a.m.
- The event will occur, rain or shine. No refunds will be issued for no-shows.

Vendor Responsibilities:

- Vendors are responsible for loading, unloading, and setting up their allocated space. Tables, chairs, and tents are not provided. There are a limited number of sixfoot tables for rent for \$10 with purchase of a parking space.
- Parking for buyers is limited, so your car needs to stay in your sales space. If you are a seller, you may not park in the buyer's section.
- It is the responsibility of sellers to bring their own change bags, to price items, and to handle monetary transactions. Please ensure you have adequate change for purchases.
- All unsold items must be packed up and removed by 4:00 p.m.
- This is a family event, items for sale must be appropriate. Offensive items, CBD products, weapons, etc. are prohibited.
- Food or drink sales, including samples, are not permitted.
- All items for sale and the vehicle must fit in the parking spaces provided. The
 following are the number of spaces available, the sizes, and the prices. You may
 purchase more than one space.

Regular parking space 51 available 20 feet x 9 feet \$25.00 Large parking space 7 available 20 feet x 15 feet \$35.00 Extra Large parking space 2 available 20 feet x 29 feet \$50.00

- Your space/vehicle must be supervised at all times. Joy in Christ is not responsible for any lost, stolen, or damaged items/vehicles
- If you have large items, such as a boat or car, you may post pictures of the item.
